The Instrument of Government (Updated in Academic Year 17.12.2021) states that the Governing Body shall consist of 11 Governors as follows:

- 2 Parent Governors / 1 Head Teacher / 1 Staff / 1 Local Authority / 6 Co-opted Governors
- * Local Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school. All Governors' terms of office are 4 years.

The Governing Body appointed Resources, Quality of Education Focus and Pay & HTPM Committees in September 2021 – other appeals committees will be appointed as and when required.

The Full Governing Body ratifies decisions following recommendation from the committees/panel above (unless otherwise stated in School Policy/Terms of Reference/Scheme of Delegation), and all minutes are available upon request made via the Clerk to Governors with the exception of confidential minutes.
